CRIMINAL LAW (CONSOLIDATION) (SCOTLAND) ACT, 1995

WARNING

It is an offence, punishable by law, for any person to enter or attempt to enter the ground:

- Whilst in the possession of a controlled container which is or was capable of holding liquid and which if thrown would be capable of causing injury to another person.
- Whilst in possession of alcohol
- Whilst drunk
- Whilst in possession of any controlled article or substance whose purpose is the emission of a flare for purposes of illumination or signalling or the emission of smoke or a visible gas.

Persons entering the ground may be searched by the stadium authorities.

CONDITIONS

This ticket is issued subject to the following conditions:-

- It shall not be resold for more than face value.
- It shall not be used as a prize in a lottery or in a newspaper or other competition without the consent of the organiser.
- The holder shall not take a camera or photographic apparatus of any description into the ground, or take cinematograph picture or photograph of any kind of the match. The holder acknowledges that any photographs taken of you by an accredited photographer inside the stadium or within the

immediate stadium perimeter may be used by the organiser for commercial purposes.

- In the event of postponement/abandonment/cancellation of a match you may be entitled to a refund (in full or in part, depending upon the circumstances) of the purchase price of the ticket. Please contact the event organiser for details.
- In the event of the abandonment of the match occurring before half-time, the retained portion of the ticket will permit admittance to the re-arranged fixture.
- In the event of the match to which this ticket admits being postponed for any reason, the retained portion of the ticket will be valid on the re-arranged date.
- The organiser reserves the right to amend the kick-off time in order to comply with any instructions by U.E.F.A. or any other relevant authority. The ticket will be valid for the re-arranged time.
- Spectators found in the wrong area may be ejected by the stadium authorities.
- The organiser, its servants or agents will not be liable for any loss, injury or damage howsoever caused to the holder of this ticket save as expressly excluded by the Unfair Contract Terms Act 1977.

The possession of this ticket shall constitute an acceptance by the holder of these conditions and imply an undertaking on the part of the holder to observe them.

In the event of any breach of these conditions the organiser reserves the right to cancel this ticket and retain the money paid therefor.

- In the event of a draw after 90 minutes, extra time of 30 minutes will be played. In the event of a draw after extra time, kicks from the penalty mark will decide the tie.
